

## **TERMS OF SERVICE**

Welcome to <a href="www.goshule.com">www.goshule.com</a>. These terms & conditions ("terms") are a legal agreement between you and Bowin brands that governs your access to and use of <a href="www.goshule.com">www.goshule.com</a> and all subdomains thereof (the "site"), including any product ordering process and all related webpages, downloadable materials, information, photos, and other materials, documentation, blog posts, or content that appears on the site ("content").
